(Agreements for a Minimum Term of 24, 36, or 60 months for print/eBook products billed on a monthly basis)

Monthly Charges begin on the date we process your order and will be prorated for the number of days remaining in that calendar month, if any. Your Monthly Charges will continue for the complete calendar months you select ("Minimum Term").

- **24-month Minimum Term** - the year-over-year increases in the Monthly Charges during the 24-month Minimum Term will be 8%.
- **36-month Minimum Term** - the year-over-year increases in the Monthly Charges during the 36-month Minimum Term will be 6%.
